**Purpose:** The document provides the basic instructions for the disassembly of products to remove components and materials requiring selective treatment, as defined by EU directive 2002/96/EC and 2012/19/EU, Waste Electrical and Electronic Equipment (WEEE).

## 1.0 Items Requiring Selective Treatment

1.1 Items listed below are classified as requiring selective treatment.

## 3.0 Product Disassembly Process

- 3.1 List the basic steps that should typically be followed to remove components and materials.
- A-1. Disassembly 2 pcs screw to remove the COVER HDD.
- A-2. Disassembly 8 pcs screw to remove the COVER rear.
- A-3. Disassembly 4 pcs screw to remove the Bracket HDD and damper.
- A-4. Disassembly 2 pcs screw to remove the Bracket Mini PCIe and damper.
- A-5. Disassembly 2 pcs screw to remove the Bracket CF.
- A-6. Disassembly 10 pcs screw to remove the Heatsink.
- A-7. Disassembly 2 pcs screw to remove the COVER iDOOR.
- A-8. Disassembly 3 pcs screw to remove the Bracket IO.
- A-9. Disassembly 4 pcs screw to PCBA touch control board.
- A-10. Disassembly 4 pcs screw to PCBA power.
- A-11. Disassembly 4 pcs screw to remove the Main board.
- A-12. Disassembly DDR module from DDR socket.
- A-13. Disassembly 10 pcs screw to remove the Bracket middle.
- A-14. Disassembly 2 pcs screw to remove the cable holder.
- A-15. Disassembly 6 pcs screw to remove the Bracket LCD and damper.
- A-16. Disassembly 1 pcs screw to remove the PCBA LED and pipe.
- A-17. Disassembly 4 pcs screw to remove the LCM.
- A-18. Disassembly 2 pcs screw.
- A-19. Disassembly 4 pcs screw to remove the easy install module.
- A-20. Remove the waterproof rubber and Front bezel.
