1 Preface

1.1 Contents of this Documentation

Parameterizable STEP 7 blocks have been created for evaluating the LEDs of the buttons of the key panels KP8, KP8F and KP32F. The present documentation describes the function and applications of these blocks.

1.2 Validity of this Documentation

The program blocks were created with WinCC (TIA Portal) V15. The blocks are collated in the STEP 7 library "Key_Panels_Library".

1.3 Context of the Documentation

The documentation refers to the following operator panels:

- SIMATIC HMI KP8/KP8F
- SIMATIC HMI KP32F

2 Scope of Application

2.1 Hardware and Software Components

2.1.1 Validity

This application is valid for

- STEP 7 Professional V15 and higher
- SIMATIC Controllers S7-1200, S7-1500, S7-400, S7-300
- Key Panels KP8 PN, KP8F PN and KP32F PN

3 Description of the Function Blocks

3.1 FC301

Validity

This chapter describes the block "LED_Control_S7_1200/1500" (FC301).

The block has to be called once for each key for which the LEDs are also to be addressed.

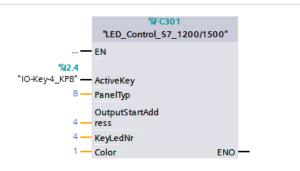
The block number and name of the FC301 can be changed as required.

The block FC301 replaces the FC300 used in the previous version. Both blocks are identical in their function.

3.1.2 Description

Each key on the key panel has an LED that can light in 5 different colors. Depending on the parameters set the LEDs can light red, green, blue, yellow or white when the key is pressed.

- The block FC301 has to be called once for each key for which the LEDs are also to be addressed.
- With the "**ActiveKey**" parameter you set the input address of the key (see section 3.1.3).
- With the "PanelType" parameter you set the number of keys on the key panel used.
- With the "OutputStartAddress" parameter you specify the start address assigned for the output address in the hardware configuration of the key panel.
- With the **KeyLedNo.** parameter you specify the LED number starting with 0 for the first button (see section 3.1.3).
- With the Color parameter you specify the color with which the addressed LED is to light.



Personal Injury and damage to property through incorrect addressing

The FC block writes the calculated color coding back to the base address of the key panel. If the address does not match the start address of the key panel or is even outside the defined address range, the data is written uncontrolled.

Under circumstances this might lead to unpredictable reactions on the machine or plant. This might result in personal injury, damage to the plant, destruction of the device and operating errors.

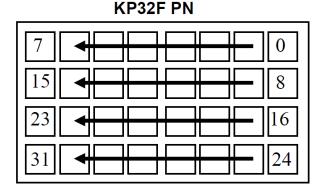
Check when configuring and during the entire operation the base address **Address** on the FC block.

Compare the address with the address in the HW Config.

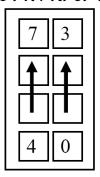

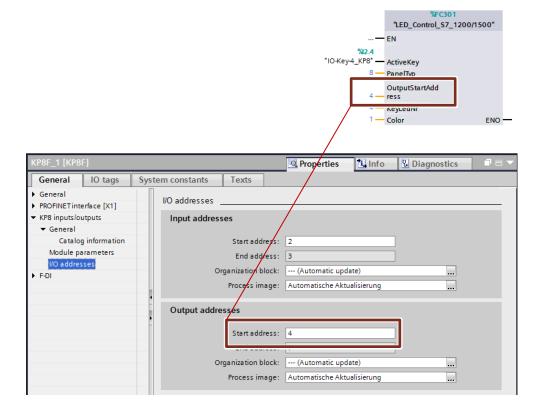
KP8 PN / KP8F PN

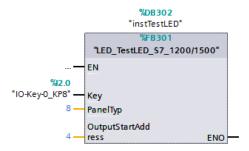


3.2 FB301

Validity

This chapter describes the block "LED_TestLED_S7_1200/1500" (FB301). Via the block you run an LED test on the KPx.

3.2.1 Parameters

3.2.2 Description

- The block FB301 has be to called once for each key panel whose LEDs are to be tested. The FB is always called at the cycle end of the OB1, because otherwise the output signals of other blocks are overwritten.
- With the "Key" parameter you set the event with which the LED test is started.
 The LEDs of all the keys are addressed one by one in all the colors.
- With the "PanelType" parameter you set the number of keys on the key panel used.
- With the "OutputStartAddress" parameter you specify the start address assigned for the output address in the hardware configuration of the key panel.



Personal Injury and damage to property through incorrect addressing

The FB block writes the calculated color coding back to the base address of the key panel. If the address does not match the start address of the key panel or is even outside the defined address range, the data is written uncontrolled.

Under circumstances this might lead to unpredictable reactions on the machine or plant. This might result in personal injury, damage to the plant, destruction of the device and operating errors.

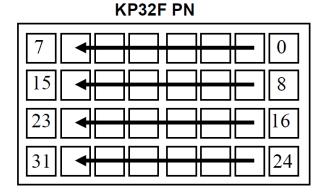

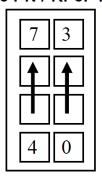

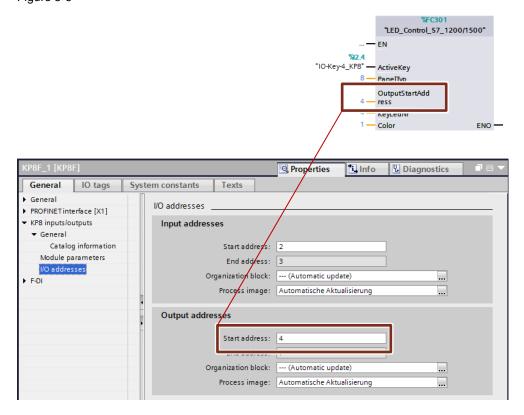
KP8 PN / KP8F PN

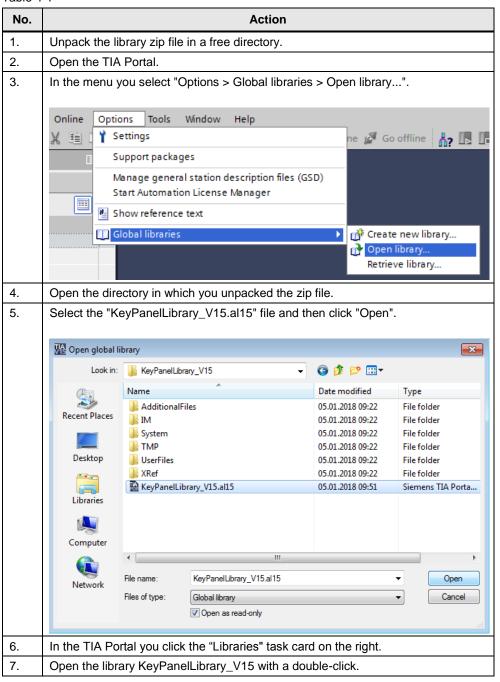


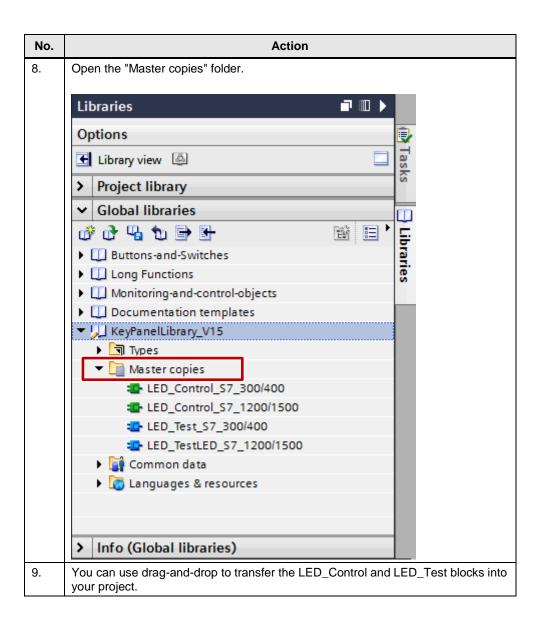

4.2.1 Introduction

The library includes the blocks for a

- SIMATIC S7-1200 or S7-1500 controller.
- SIMATIC S7-300 or S7-400 controller.

Block number	Block name	Function
FC300 / FC301	LED_Control	Addressing of the LED for the assigned key on the key panel. Possible colors: red, yellow, green, blue and white. Color and position of the key are set as assignable parameters on the FC. (See Table 3-1)
FB300 / FB301	LED_Test	Lamp test: addresses all the LEDs of the complete key panel.

4.2.2 Procedure

The following example is for a SIMATIC S7-1200 or S7-1500 controller. The procedure for an S7 300/400 controller is the same.

No.	Action
1.	Drag-and-drop the "LED_Control" block from the library "KeyPanelLibrary_V15" into the program editor.
2.	Open the organization block "Main".
3.	Insert the function block "LED_Control" into a network.
4.	Set the inputs as given in Table 3-1 and section 0 (for FC300) and in Table 3-2 and section 3.2.2 (for FB301). Comment **FC301 1ED_Control_57_1200/1500*— EN **IO-Key-4_KP8* — ActiveKey 8 — PanelTyp OutputStartAdd 4 — ress 4 — KeyLedNr 1 — Color ENO —
	Tip: If you put the cursor on a parameter, a tooltip opens showing all the possible inputs.
5.	After successful parameterization you download the configuration to the controller and .test the function
