Now the environmental protection has been taken more and more attention globally, and the concept of sustainable development also has influence on the textile industry, thus, the recycled cashmere derived.

Recycled cashmere is actually the recycling and reutilization of cashmere fibers, and which are divided into:

1. Pre-consumer, this includes the fiber wastes generated during spinning process, and then recycles and remakes into yarns.
2. Post-consumer, this is to recycle the finished sweaters and reuse.

In order to reduce and eliminated the harm caused by its production, and let retailers and consumers understand which parts of a specific product are made of recycled materials, our company has developed the blends of recycled cashmere with regular cashmere and wool fibers so that we can achieve the balance on quality and performance.

Recycled cashmere is not having the price lower than regular cashmere because recycle is not equal to cheap. On the contrary, recycled cashmere or wool is more difficult to handle during spinning process comparing new cashmere or wool, which needs higher requirements on the spinning workmanship to reach the proper yield.

2/26NM 60% recycle cashmere 40% cashmere is suitable for 12gg knitting. The advantage of this product is soft, and the proportion of 60% recycled cashmere is relatively high, which balances the softness and the realization of the use of the recycled cashmere.

Recycled cashmere is actually a belief, a mission, and a compromise made by mankind for nature. Advocating recycled energy is what each of us needs to do and practice.
